## Welcome to 2020...

he new year has started off with a bang, as the campaign season has heated up, state agencies busy themselves implementing laws passed in 2019, and lawmakers begin their interim hearing schedule. Here is what you need to know in 2020:


Medical Billing Services: Recently, the Texas Comptroller of Public Accounts set forth a new policy for taxation of medical billing services. Under the new policy, effective April 1, 2020, medical billing services performed by external third parties will be subject to state and local sales taxes.

The origin of this shift in policy is somewhat murky. In 2002, the Comptroller's office reviewed this same question - whether medical billing was "insurance claim adjustment or claim processing" and therefore taxable - and determined that it was not. Now, the Comptroller's office has reversed this policy. To add to the confusion, insurance services performed by employees are not taxable, nor are contracted services performed for certain non-profits – only those services provided by an external third party to for-profit medical providers.

The Texas Medical Association recently convened a large stakeholder group to discuss next steps. Outreach to the Comptroller's office and lawmakers is underway, and may result in further modification to this new policy, or delays in implementation. However, until more

certainty is reached, medical providers who contract with third parties for their billing services could see their costs go up. Stay tuned for further developments.

Prescription Monitoring: You may already know that beginning on March 1, 2020, H.B. 3284 (86th Texas Legislature, 2019) requires medical providers to check the Texas Board of Pharmacy's Prescription Monitoring Program (PMP) database prior to prescribing or dispensing opioids. In an effort to inform providers about their obligations under the new law, the Texas Medical Board (TMB) proposed initial guidance that would have required providers to check the PMP for every patient upon admission to a facility, and would have applied to

inpatient as well as outpatient medication orders. The TMB later held stakeholder conversations about that initial guidance and other efforts to implement H.B. 3284.



## Burnout or Moral Injury; What You Can Do About It

'd like to talk about the "work-related syndrome involving emotional exhaustion, depersonalization and a sense of reduced personal accomplishment,"1 that can be accompanied by a lack of empathy for patients. Yes, you are all familiar with physician burnout. In the Physicians Foundation's "2018 Survey of America's Physicians: Practice Patterns and Perspectives," 77.8% of physician respondents reported having feelings of professional burnout, either sometimes, often or always. In the survey, respondents reported they spend 23% of their time on non-clinical paperwork. And the 2 factors physicians disliked the most were electronic health records and the loss of autonomy.2

I recently read a guest editorial, "Reframing Clinician Distress: Moral Injury Not Burnout". From the editorial, the authors write that moral injury "occurs when we perpetrate, bear witness to, or fail to prevent an act that transgresses our deeply held moral beliefs. In the health care context, that deeply held moral belief is the oath each of us took when embarking on our paths as health care providers: Put the needs of patients first." Instead, physicians are expected to yield to the expectations of health care systems/hospitals/HMOs (e.g., productivity metrics), health insurance companies (e.g., prior authorizations), electronic health records (e.g., extra hours of documentation), etc. Using the term burnout suggests a failure of resourcefulness and resilience on the part of

the physician, whereas moral injury points to systemic causes of burnout.3

So, what can one do? First, take care of yourself. Schedule time for yourself and stick to that. Many of us may choose to "tough it out" when we are feeling distressed and don't want to involve/worry others. Check-in with your colleagues/residents/fellow, especially if you notice they have distanced themselves from you and others. You can be the one who helps a colleague through a rough time or impending/actual burnout.

Establish support and guidance with others. I am on the APA College Mental Health listserv, where I can turn to colleagues at universities throughout the country for questions and guidance. Some of my colleagues who are in private practice have set up e-mail communication with local psychiatrists where we ask questions of each other (how do you handle this situation?) or can ask others for help (e.g., recommended referrals for patients). You can find support with colleagues at TSPP.

Talk to your supervisor. Administrators should support clinician satisfaction and work to implement organization level solutions. If not, then one may need to reassess your ties with that organization.

Get involved with organized psychiatry. Physician leaders, including leadership at TSPP, have a responsibility to communicate with legislators and influence policy. Our active participation in the legislative process has made the difference in the passage of leg-

islation or killing of a bill. Some of TSPP priorities this past year have included: Scope of Practice (e.g., we testified against a bill on Psychologist Prescriptive Authority; that bill died in committee); Emergency Room holds (we have a representative participating on a Task Force to develop common understanding of the law regarding emergency detentions and OPCs); and Mass Violence/Public Safety (we have a representative who has been involved in the hearings on mass violence and public safety in both in the Texas House and the Senate).

Your involvement can contribute to making changes in the interest of our patients and Texas psychiatrists. 

In those discussions, the medical provider community expressed significant concerns about the impact the guidance would have on facility operations and medical treatment.

Accordingly, the TMB released revised instructions to providers, clarifying that the mandatory PMP check is required only when opioids, benzodiazepines, barbiturates, or carisoprodol are prescribed to a patient for take-home, unsupervised use. When such prescribing takes place upon discharge from either an inpatient or outpatient setting, a PMP check is required. A mandatory check of the PMP is not required before, upon admission, or during an inpatient or outpatient stay in a medical facility – only when the patient is released from care with a prescription for a covered medication to be taken in an unsupervised setting.

Additionally, a doctor may delegate the requirement to check the PMP to any legally authorized personnel, much in the same manner as physicians delegate other tasks. Such designees may include nurses, physician's assistants and administrative personnel. Lastly, a copy of the PMP check should be placed in the patient's medical records, to document compliance with the law's requirements. More information about the PMP check can be found at the TMB website: www.tmb.state.tx.us.

**Prior Authorization:** The House of Representatives has now named their members to the Joint Committee on Prior Authorizations, and we are eagerly awaiting the Senate appointments. The Joint Committee will look for ways to reduce, streamline and/or eliminate prior authorizations. The Federation worked extensively on reducing prior authorizations for antipsychotics during the legislative session, partnering with TMA and other advocacy groups to further that effort, and have already begun conversations with House offices about eroding burdensome authorization requirements that are designed to save a dollar in drug costs, but lead to millions of downstream costs, including increase hospitalization, re-admissions, homelessness, substance abuse and criminality – not to mention being burdensome on physicians.

If you have tales of outrageous or frustrating prior authorization requirements, the TMA is collecting such anecdotes for use during the Joint Committee's deliberations. TMA's website (www.tma.org) has more details, and would welcome your feedback

Senate Bill 362 Task Force: S.B. 362 (86th Texas Legislature, 2019) included provisions sought by the Federation creating a Task Force under the leadership of the Texas Supreme Court to increase access to courts for emergency detentions and orders of protective custody. That Task Force has had several meetings and is showing progress, particularly in exploring technological solutions to increase court access for emergency detention warrants. They are also looking at consolidating and standardizing the forms that are used for detentions, and how to require or otherwise encourage the adoption of these new processes by various jurisdictions. Much of these changes can be developed through the Supreme Court rules process, but the Task Force is also looking at what

statutory changes could be helpful.

Appropriations: The Federation, along with TMA and other specialties, filed recommendations with the Health & Human Services Commission for appropriations to consider in the 2021 legislative session. We identified a priority of alleviating the lengthy backlog of inmates with mental health disorders awaiting psychiatric forensic consultation, competency restoration, or court ordered treatment by seeking funding for five additional forensic psychiatric fellowships.

Forensic psychiatrists provide psychiatric evaluations of individuals involved with the legal system as well as specialized psychiatric treatment for inmates or state hospital patients who require psychiatric competency restoration before standing trial. However, there are too few specialty trained psychiatrists to meet the demand. Increasing the number of psychiatric forensic fellowships to five will support the pipeline of psychiatrists with the expertise and ability to work in the state's criminal justice and state hospital systems and relieve backlogs of mentally impaired inmates awaiting assessment, treatment, or trial.

**Patient Information Disclosure Discussions:** The Hogg Foundation for

Mental Health recently convened a stakeholder meeting to discuss the sharing of confidential mental health and substance use medical/health information. The meeting was a follow-up on discussions held during the legislative session surrounding HB 3519, which failed to pass. At the meeting, the Federation, TMA, NAMI and a variety of patient & family stakeholders discussed what is allowed under current federal HIPPA laws as well as current state law. We also heard from family members about why they feel that changes to current statute is necessary, as well as from individuals with lived experience regarding their concerns and perspectives related to sharing of confidential information. We anticipate continuing the discussion in 2020 with a goal of reaching some consensus on recommendations to the legislature for reforming the law in 2021.

#### **CME PROGRAM GOAL / TARGET AUDIENCE**

Diagnostic and treatment methods to address conversion disorder, somatic symptoms disorder, illness, anxiety disorder are needed for improved recognition and clinical outcome.

Side effect of psychiatric medications is an everyday occurrence in the psychiatric practice. It contributes to noncompliance of treatment recommendation, medical misadventure, morbidity, missed opportunities in achieving the treatment goals.

Not enough waivered physicians to prescribe Suboxone. Psychiatrists often don't have training or knowledge to help their patients with OUD.


