


On April 28th, TSPP will conduct our Spring Meeting. Your attendance and



# **Legislative Update**

The 181 members of the Texas Legislature filed 5,921 bills by the deadline of March 9, an increase of 13% from 2005. Of these bills, the Federation is tracking 315 bills that could effect the practice of psychiatry in Texas, categorized as follows:

**TELEMEDICINE: Permits HHSC to reim**burse under Medicaid telemedicine medical service provided by a physician who is assessing and evaluating the patient from a distant site if an advanced nurse practitioner or physician assistant acting under the delegation and supervision of that physician is present with the patient at the time the service is provided, the nature of the service is follow-up treatment under a treatment plan previously established for the patient by the physician following a diagnosis of a medical condition after an in-person consultation between the patient and the physician, and, the medical condition for which the patient is receiving the service is not likely, within a reasonable degree of medical certainty, to undergo material deterioration within the 30-day period following the date of the service. Status: Passed the Senate 3/28/07; Referred to House Public Health 3/30/07.

SB 30 Jane Nelson

Board must pass each part of the examination within three attempts, except that, if the applicant has passed all but one part of the examination within three attempts, the applicant may take the remaining part of the examination one additional time. However, an applicant is considered to have satisfied the requirements if the applicant: passed all but one part of the examination within three attempts and passed the remaining part of the examination within six attempts; is specialty board certified; and has completed in this state an additional two years of postgraduate medical training approved by the board.

**HB 197** Yvonne Gonzalez Toureilles FAMILY VIOLENCE: Includes a provision requiring the accreditation of providers offering services for battering intervention and prevention services as well as the development of guidelines for battering intervention and prevention services. The accreditation and guidelines will be issued through the Community Justice Assistance Division of the Texas Department of Criminal Justice.

EMERGENCY DETENTION: Specifies that jails or nonmedical facilities used to detain persons charged with or convicted of a crime are not a suitable facility for detention of persons taken into custody under mental health detention.

ACCESS TO HOSPITAL RECORDS: Allows an agent of a person who lacks capacity to make health care decisions to access the medical records of the person upon admission and access to any records in the possession of the hospital related to the persons' condition or treatment related to admission.

#### SB 591 Jane Nelson

TEXAS MEDICAL BOARD: Each license holder shall submit to the Texas Medical

MEDICAID REFORM: A major bill designed to increase access to health insurance and to ensure that services are delivered as efficiently as possible under the Medicaid program. Provisions relating to Medicaid patients: rewards patients who complete smoking cessation, weight loss and other preventative programs; encourages Medicaid managed care plans to enroll patients in "value-added" preventative health services; creates customized benefit plans that are tailored to a patient's individual health care needs; creates a pilot program for Health Savings Accounts under Medicaid, which would be optional; expands the effort to assist with the cost of premiums for those who are Medicaid-eligible but have access to employer-based plans; and allows individuals to voluntarily opt out of Medicaid in exchange for the state paying the employee's portion of premiums for employer-based coverage. Provisions relating to Medicaid costs: expands efforts to stop fraud and abuse; authorizes co-pays for non-emergency visits to hospital emergency rooms, providing that there are alternative health care options available; standardizes the way hospitals report uncompensated care to eliminate guesswork involved in the state's cost projections; and evaluates possible expansion of integrated care management to areas where it is currently unavailable. Provisions relating to the uninsured: develops a "3-Share" or "Multi-Share" model in which the state can partner with employers and local governments or charitable entities to connect Texans with health coverage;

apitol Day for the Federation of Texas Psychiatry took place on February 28 of this year. We enjoyed a good mix of people (including members of our member organizations, members of allied organizations, members-in-training, the experienced and the inexperienced regarding legislative contacts, men and women, and a wide range of political perspectives) to do this work. Everyone did well, and all were effective in their efforts to convey the important political messages of the day. Those who stated that they were inexperienced or completely without experience in dealing with legislators all did a fine job. Due to the demands of the legislative session that day, many of us were unable to speak with legislators themselves. Those who were able to do so enjoyed a good response. The rest of us experienced varied receptions and responses from different chiefs of staff/legislative aides/etc., but our efforts were well-received overall. In short, we were effective, and Capitol Day 2007 was successful.

It appeared that everyone involved enjoyed the wrap-up session late that afternoon back at the TMA building. The issues we chose to emphasize that day included, but were not limited to, access issues regarding emergency psychiatric care, funding for graduate medical education, insurance coverage for psychiatric care, and scope of practice issues (especially regarding prescribing privileges and admitting privileges for psychologists).

We did our best to represent important issues for all of our member organizations, both voting members (Texas Society of Psychiatric Physicians, the Texas Academy of Psychiatry, the Texas Society of Child and Adolescent Psychiatry) and associate members (the Texas Medical Association, the Texas Osteopathic Medical Association, the Texas Foundation for Psychiatric Education and Research). Scope of practice issues, regardless of specialty, are of great concern to all physicians—our efforts, legislative, educational, and otherwise, must lead to protecting our patients from those who would choose to attempt to act as physicians without completing the rigorous and necessary training to do so. Therefore, the Federation must seek to effectively represent the interests of all of our member organizations, and we will always endeavor to do so.

As just one means of achieving this objective, TSPP's active involvement in the TMA's Interspecialty Society Committee over the years has proven invaluable both to TMA and to TSPP. TSPP representatives were instrumental in testifying in Austin in the recent past on behalf of tort reform and reform of the then Texas State Board of Medical Examiners. TSPP representatives have also helped to bring focus on the need to attend to all medical scope of practice issues. In return, TMA, the most successful and effective organization of its kind in the United States, has helped all of psychiatry with scope of practice and other issues, as well. *All psychiatrists in Texas should belong to the TMA in addition to our specialty organizations*.

The deadline for filing new legislation was March 9. By the time of that deadline, neither a psychologist prescribing bill nor a psychologist admitting bill (an idea resurrected for the first time since 1993) had been filed. While this is great news, and hopefully illustrates the effectiveness of the Federation, we should keep in mind that such aims and desires can be attached to other, often non-related, legislation, so that we must remain alert for the good of our patients. Keeping track of the nearly 400 bills filed this legislative session that pertain to psychiatric health care is not an easy task, but our Executive Director John Bush, our Assistant Director Debbie Sundberg, our lobbyist Steve Bresnen, and TSPP's Government Affairs Committee Chair

Martha Leatherman, MD, of San Antonio, all do a fine job of monitoring legislation, of maintaining contacts with legislators, and of educating both legislators and the general public on all of these issues. My hat is off to all of them.



he Texas Society of Child and Adolescent Psychiatry will hold its annual meeting July 27-29, 2007 at the Moody Gardens Hotel in Galveston, Texas. The theme of the meeting will be, "New Directions in Child and Adolescent Psychiatric Treatment." (See page 7)

We plan to delve into new advances in clinical neuroscience that will shape the practice of psychiatry in the next five years: pharmacogenetics, brain stimulation methods and the ethics of psychopharmacology in children and adolescents. Our keynote

speaker will be James T. McCracken, MD, the Chief of the Child Psychiatry Division of the University of California at Los Angeles. Dr. McCracken and his faculty are some of the leading researchers in the world in the genetics of psychiatric disorder. In the future, pharmacogenetic assays will help predict response to treatment and identify patients vulnerable to side effects.

In the last few years, brain stimulation tasks such as magnetoencephalograpy (MEG), vagal nerve stimulation (VNS) and deep brain stimulation (DBS) have been

developed for research into and treatment of psychiatric disorder. VNS is currently approved for treatment of adult depression and epilepsy. We will review the basic principals of these techniques and have a case presentation of a child with comorbid major depression and epilepsy whose depression responds when his epilepsy was treated with VNS.

Finally, we will have a presentation and panel discussion on psychiatric polypharmacy in children which will qualify as the ethics credit of your continuing medical education (CME) annual requirement. There is great public concern about the use of psychotropics in children; there are a growing number of complaints being filed with the Texas Medical Board against psychiatrists on this issue. It is critical for all Texas psychiatrists to be aware of the local trends in this area.

Our business meeting focuses on political and economic trends affecting child and adolescent psychiatrists in Texas. As part of the Texas Federation of Psychiatry, the Society is your advocate in Austin. Members of the Society's Executive Committee have been to Austin to speak to legislators and their staff on a number of proposed laws. This year, the Society has worked to prevent the passage of bills which would have restricted your ability to
