### **They Have Not Gone Home Yet!**

s you know the Legislature is still in session and will not finish its business until the end of May. The Legislature can still enact much legislation in this, the 82nd session. As in years past, the impact on patient care is a mix of what has been proposed, how your Federation reacts and how the legislators respond to our feedback and suggestions. You should know that your Federation of Texas Psychiatry, and its public policy consultant, Eric Woomer, is on the job, monitoring the thousands of proposed bills. So, where does care for our patients stand at this point in the 82nd session? What have your patients received for your TSPP dues this session?

Eric has already intervened in a number of areas important to the care of our patients. As in the past the Federation prioritize the proposed bills. Priorities are set depending upon how close a bill comes to the Federation's core legislative principles. For those of the highest priority, the public policy consultant devotes all lobbying effort; for those of important interest, he monitors and helps shape the outcome; for those of lowest priority, he monitors but does not spend much time influencing the outcome.

Your Federation is most concerned about legislation that: improves access to quality psychiatric care, ends discriminatory practices toward persons with a psychiatric diagnosis, maintains fairness in the appropriate regulation of medicine and insurance / managed care industry practices and protects patients' rights and privacy. In addition, your Federation works to oppose attempts by non-physician providers to expand their scopes of practice that could be harmful to patients in need of quality psychiatric care and opposes attempts to legislatively ban or impede access to scientifically proven psychiatric treatments, denying patients of choice and interfering in the physicianpatient relationship.

Here are some of the things that the Federation has accomplished so far:


Rep Brown removed from HB 3678 an onerous provision which would have directed HHSC to eliminate off-label prescribing of anti-psychotics; this was a key victory for many of us who use anti-psychotics to prevent serious harm and injury to our patients, their families and others.

Rep. Strama struck his original bill that

would have prohibited physicians from prescribing more than four medications of any kind for children in foster care; he rewrote language to reflect current HHSC rules developed through the STAR Health process regarding monitoring polypharmacy in the foster population, a process which is supported by the Federation. Again, this change was important as it meant that children with complex psychiatric problems and complicated medical histories can receive appropriate medical care.

A bill by Senator Zaffirini directing HHSC to prohibit the PRN injection of psychoactive medications with limited exceptions has been slowed and stalled. The Federation continues to educate legislators about the potential harm of this proposed legislation.

Of course, there are many things that the Federation has no control over, most prominently, the budget shortfall. This shortfall will heavily impact all areas of discretionary spending including all of various social services. As of the time of this edition, it is unknown how the Senate and House will reconcile the differences. It is unlikely that mental health care in outpatient and hospital settings will be

spared; that means many of those patients will end up in other, much less appropriate settings such as emergency departments and jails, all of which are much more costly and less effective. This may lead to a repeat of the events of 2004 when a similar cost-cutting move led to overcrowded jails and emergency departments stretched beyond capacity.

While the Federation cannot change the fiscal picture of the state budget, you can rest assured that your dues will be used to vigorously intervene with legis - lators to prevent bad ideas from being enacted into bad practices through inappropriate regulations.

#### Children's Mental Health Awareness Week

ay 1-7, 2011, is National Children's Mental Health Awareness Week.
Approximately 1.2 million Texas children live with mental illness, and of those, nearly 300,000 live with serious mental illness such as depressive, psychotic and bipolar disorders. Yet, the majority do not receive treatment.

A child in Texas has less of a chance to receive necessary mental health treatment than children living in any other state.

Texas ranks 49th in per capita mental health funding at \$34.57 — well below the national average of \$103.53.

Our legislators recognize that untreated

Texans with serious mental illness get caught in an expensive revolving door of crisis, emergency rooms, hospitalizations and involvement in the criminal justice system. In 2007 and 2009, the Texas legislature wisely invested in a crisis mental health system to help address mental health issues upstream where the biggest savings can be realized. However, given the state's dire fiscal circumstances, spending for this fragile population is in serious jeopardy. The budget passed by the Texas House of Representatives imposed a 19% reduction in children's mental health services in the community mental health centers. The Texas Senate is proposing restoring full funding, but this still falls short of the community's needs. These centers already operate beyond their capacity, and families newly seeking services are sometimes told of waits as long as 2 to 5 years.

Additionally, despite the positive effects of crisis intervention, young Texans who present as an imminent danger to themselves and/or others, and require hospitalization, often find the state and private psychiatric hospitals at

capacity. These patients in crisis are forced to remain in emergency rooms for hours or days until a psychiatric bed is available. Many of these patients and families end up traveling outside of their county, often over 120 miles away, to receive inpatient services. This delays treatment and costs taxpayers more.

For children and adolescents, mental illness, left untreated, can lead to tragic consequences, including school drop-out, involvement with law enforcement and suicide. Suicide is the third leading cause of death for 11-18 year-olds in Texas. Almost as many teens die by suicide as those who die from all natural causes combined.

Serious mental illnesses are biologically-based illnesses that deserve the same consideration and protection as chronic medical illnesses. The good news is that when we identify and treat mental illness early, we can improve outcomes and help our youth lead productive lives. TSCAP urges the Legislature to protect this fragile population by restoring funding for state hospitals and community centers. It's a smart invest-

TPHP is a new confidential, non-disciplinary statewide program for physicians, physician assistants, acupuncturists and surgical assistants licensed by the Texas Medical Board. The program was created by Senate Bill 292 of the 81st Texas Legislature and is modeled on other states' programs and was a joint effort of the Texas Medical Association, the Texas Osteopathic Medical Association and the Texas Medical Board. The program is designed to protect the public by encouraging health professionals to seek assistance with drug or alcohol-related problems or mental or physical conditions that present a potentially dangerous limitation or inability to practice medicine with reasonable skill and safety.

#### SCIENTIFIC PROGRAM GOAL / TARGET AUDIENCE /LEARNING OBJECTIVES


