88th Texas Legislature: Overview

fter a five-month whirlwind, the 88th Texas Legislature adjourned Sine Die on May 29th. Members filed a remarkable total of more than 8,000 bills, passing 15%, including important legislation related to grid reliability, teacher retirement system funding, ending gender modification procedures for minors, extending Medicaid eligibility for new mothers to a full year, protecting consumer data, and reducing the risks to children from social media. However, tension and disagreements between the two chambers' leaders left big-ticket items undone at the close of session, including property tax relief, public school voucher, teacher pay raises, and border security.

As anticipated, Governor Greg Abbott called the Legislature back immediately for a First Called Special Session with two items on the call: property tax relief through tax compression and border security by addressing human trafficking. The House and Senate gaveled back in on May 30th, and within days, the House passed their versions of legislation aligned to the Governor's call, and then adjourned for the remainder of the special session. The Senate continued working for the full 30 days before adjourning on Tuesday, June 27th.

The timing of the special session coincided with the Governor's veto period, which ran through June 18th. Gov. Abbott extensively leveraged his veto power in a fruitless attempt to garner a compromise between the chambers on the property tax issue. In the end, Gov. Abbott vetoed 76 bills, a personal record, second only to Governor Rick Perry at 83 in 2001.

Given the failure to pass any legislation in the first called session, Gov. Abbott wasted no time calling lawmakers into a Second Called Special Session, which began immediately on June 30th, and focused solely on property taxes. At this time, the House and the Senate are searching a pathway for a compromise to grant more than \$17 billion in property tax relief.

members. Second, the House voted 121-23 to adopt twenty articles of impeachment against Attorney General Ken Paxton for misuse of his office. It is the first such impeachment since 1975. General Paxton has been removed from office pending trial in the Senate, which has been scheduled to begin September 5th. As of late, Paxton has indicated that he will not testify at the trial, but the Senate can compel him to do so. 88th Texas Legislature: Appropriations, Federation Priorities and Other Legislation

Returning to more conventional legislative activities: Mental health was a top priority for the Legislature as it has been over consecutive sessions, and significant investments were made in addressing mental health from many angles. On the budget side, the appropriations for strengthening

mental health services totaled over \$9 billion to support programs administered by the Health and Human Services Commission (HHSC). These include funding areas such as mental health community hospitals, new and ongoing construction of state hospitals, expanding competency restoration and addressing forensic waitlist, additional dollars for high-risk children programs including new services specifically helping the community of Uvalde, and much more.

Additionally, budget writers adopted an additional \$99 million for Graduate Medical Education to continue moving Texas forward in achieving a 1:1 ratio for residency positions. Appropriations also addressed

1wo other inauspicious issues made the 88th Legislature particularly noteworthy. First, the House voted to expel Rep. Bryan Slayton due to his inappropriate behavior and misconduct with one of his female staff

workforce shortages including investing new general revenue dollars to support psychiatry programs at our higher education institutions. The Federation led an effort to fund additional forensic psychiatry fellowships, and successfully secured \$5 million for the 2024-25 biennium to support that effort. This program will be administered by the Texas Higher Education Coordinating Board (THECB), and we are currently working with the agency on implementation.

The Texas Child Mental Health Consortium, another priority for the Federation, received \$280 million for the biennium to support and expand the Consortium's programs and services. Additionally, an effort led by a coalition of mental and behavioral health advocates, including the Federation, resulted in the Mental Health Loan Repayment Program receiving a significant increase in appropriations (from \$2 million over the previous biennium to \$28 million for the next cycle), as well as two bills expanding the eligibility of the program, House Bill 2100 by Rep Four Price/Sen. Charles Schwertner and Senate Bill 532 by Sen. Royce West/Rep. John Kuempel.

Our team tracked over 350 bills for the Federation across a diverse set of policy issues. Here is a snapshot of the outcome:

Federation Priorities:

Psychiatry Innovation Grant/Behavioral Health Innovation Program: HB 400 by Rep. Stephanie Klick addresses workforce shortages in psychiatry through creating two new grant and merit-based programs. It creates the Psychiatry Innovation Grant program to support the state's health related institutions, and establishes the Behavioral Health Innovation Program to award incentive payments to institutions of higher education for innovative training and retention programs to increase the number of mental health professionals. The legislation was signed by Gov. Abbott, but there not an appropriation made to fund these programs at the THECB, which limits implementation opportunities. That issue likely will need to be addressed in the 2025 session.

Step Therapy Protocols for Serious Mental Illness: The Federation was successful in passing HB 1337 by Rep. Lacey Hull, which regulates step therapy protocols under commercial insurance for prescription drugs for serious mental illness. HB 1337 is one of two bills where the Federation led advocacy efforts to address barriers to mediation access for serious mental illness. In 2021, we passed SB 2822 that streamlined the prior authorization process around antipsychotics under the Medicaid program, and now in 2023, we were able address commercial insurance with the passage of HB 1337. The legislation was signed by Gov. Abbott and is effective on September 1, 2023. Emergency Detention Orders: HB 3504 by Rep. Jeff Leach was the primary vehicle for streamlining the emergency detention process and allowing the use of technology to quickly communicate with judges where needed. The Federation and other advocates have been working on this issue over consecutive sessions. The bill passed the

House and was referred to the Senate Criminal Justice, but no further action was taken. However, our team was able to get key provisions of the bill amended into SB 1624 by Sen. Judith Zaffirini, which was signed by Gov. Abbott and is effective September 1, 2023.

Psychology Prescribing: HB 343 by Rep. Vikki Goodwin was familiar legislation for the Federation, granting independent practice of psychologists. The Federation met with Rep. Goodwin during the interim prior to session to share our concerns and opposition to the bill. While the bill was referred to House Public Health, no further action was taken, killing the bill for the session.

Advanced Practice Registered Nurses (APRN) Independent Practice: HB 4071 by Rep. Klick and SB 1700 by Sen. Cesar Blanco would have given certain APRNs the ability to practice independently in specific settings. These bills did not recieve a hearing in either the House or Senate, and died for the session.

Other Legislation:

SB 26 by Sen. Lois Kolkhorst was omnibus legislation related to mental and behav-

ioral health that touched state hospitals, mental health waitlists, competency restoration and step-down options, and transparency by the local mental health authorities and behavioral health organizations. It created the Innovation Matching Grant Program for Mental Health Early Intervention and Treatment, which requires HHSC to establish a matching grant program to support communitybased initiatives that promote identification of mental health issues and improve access to early intervention and treatment for children and families.

Sen. Kolkhorst also filed SB 595 which would have enhanced parental consent procedures for public schools when conducting psychological or psychiatric examinations, tests, or treatments on students. A number of mental health advocates and providers were concerned that SB 595 was overly broad and constrictive, and the bill died in the House. However, Sen. Kolkhorst amended its provisions onto another controversial bill, HB 890, but the House failed to take further action on that legislation, so it died as well.

HB 2337 by Rep. Tom Oliverson would

have provided intensive outpatient services and partial hospitalization services under Medicaid. The bill made it over to the Senate, but never received a hearing. Rep. Oliverson was able to amend the bill's provisions into SB 1677 by Sen. Charles Perry, but concerns by Senate leadership led to the language getting stripped out in conference.

Several bills with scope of practice implications were filed by multiple members, and the Federation worked with the House of Medicine to protect physician practices. Of note, two guardianship bills ultimately included language to address scope concerns – HB 3009 by Rep. Gary Vandeaver, which added provisions increasing supervision requirements for APRNs, and SB 1624 by Sen. Zaffirini, which included provisions limiting the role of psychologists in guardianship proceedings to the confines of their licensed authority.

With no property tax compromise on the immediate horizon, observers expect the House and Senate to continue to meet in special sessions in the near term. The impeachment trial of Gen. Paxton begins in September, 2023 and is expected to run all month, and most political watchers expect Gov. Abbott to call a special session in the October time from to address public school vouchers, and perhaps other issues. It looks to be a long, hot summer and fall in Austin. As always, thank you for allowing us to be your voice at the state Capitol.

COUNCIL ON EDUCATION

CONTINUING MEDICAL EDUCATION: To develop the Scientific Program for the Texas Society of Psychiatric Physicians' Annual Meeting in accordance with the Essentials as outlined in the Texas Medical Association's CME Guidelines, after receiving approval both from the Executive Council and the Finance Committee for particular plans; and, to assist the President-Elect in the development of the Scientific Program for the Texas Medical Association Section on Psychiatry.
