88th Texas Legislature: Property Tax Relief, Paxton Trial, and a Third Called Special Session

espite the traditional end of the Regular Legislative Session in May, the Legislature has continued to work. The House and Senate were called back to business by Governor Greg Abbott earlier this summer for two Special Sessions. The focus was on lasting property tax cuts as well as building a pathway towards eliminating school property taxes. After a failed First Called Special Session in June, the two chambers were able to find a compromise in the Second Called Special Session in July, passing a \$18.6 billion property tax relief package that includes a combination of tools to help homeowners and businesses in Texas. Gov. Abbott signed SB 2 and SB 3 on July 22nd, which included provisions compressing the school tax rate by more than \$7 billion, an increase in the homestead exemption to \$100,000, a temporary 20% appraisal cap, and franchise tax

After a little over a month back in their districts, members of the Texas Senate returned to Austin to begin the impeachment trial of Attorney General Ken Paxton. The proceedings began on September 5th, and after two weeks of testimony and arguments from both sides, the Senate voted to acquit Paxton on all sixteen articles of impeachment. Two Republican senators, Sen. Robert Nichols and Sen. Kelly Hancock, broke ranks to vote for conviction on some articles, while the majority of Republicans supported acquittal. The articles of impeachment against Paxton primarily accused him of accepting bribes and abusing his office. During the trial, seven former senior Paxton aides testified about their concerns regarding Paxton's relationship with Austin real estate developer Nate Paul and their decision to report him to the FBI. Upon conclusion of the proceedings,

Lt. Governor Dan Patrick called for changes to the impeachment process and an audit of impeachment expenditures.

The fallout from the trial has widened the divide between the House and Senate and significantly sharpened the tensions between the Lt. Gov. Patrick and House Speaker Dade Phelan as both leaders took aim at one another on various media platforms. Speaker Phelan is also under attack by his own party, after the State Republican Party approved a resolution seeking his resignation and some House members have indicated that they will take action to unseat the Speaker during the upcoming special session. However, Speaker Phelan is not alone in drawing fire from the trail. GOP House members (and possibly some senators) may face further retribution from more GOP hardliners in the March, 2024 primary.





Amidst all this tension, the Legislature is reconvening for a third special session. On September 26th, Gov. Abbott sent a letter to the House and Senate leaders, informing them that lawmakers would be called back on October 9th at 1:00 p.m. While school choice is expected to be the primary focus, border security and some of the legislative priorities that were vetoed by Gov. Abbott could find a place on the agenda.

On a separate note, September 1st marked the start of the state's new fiscal year and the recently-approved budget going into effect. Also, 773 new laws became effective as well.

November 2023 General Election: Constitutional Amendments and House District 2

Voters will head to the polls on November 7th to consider a total of fourteen proposed constitutional amendments. The propositions before Texas voters include some major issues for Texas such as implementation of the property tax relief passed during the special session, funding water infrastructure, broadband expansion by

establishing a dedicated fund to assist expansion, investing in the electrical grid and energy reliability through the creation of an energy fund to support the construction and operation of generation facilities, a cost of living adjustment (or COLA) for retired teachers, and more. If you want more information on the 14 proposed constitutional amendments, please visit the Secretary of State's website at www.sos.texas.gov.

Voters of House District 2 will also go to polls on November 7th to choose their candidate to serve out the expired term of Bryan Slaton, the lawmaker expelled by his House colleague for his misconduct with a former staffer and abuse of the office.

Early voting begins October 23rd, running through November 3, 2023.

Elections in 2024:

March primaries are not far away with candidates having until December 11th to file their intent to be on the 2024 ballot. While the field of candidates is still unfolding, eleven Texas House members have decided not to seek re-election in 2024, with a handful looking at higher office runs. Members that are not returning in 2025 are:

> Rep. Four Price (R-Amarillo) Rep. Abel Herrero (D-Robstown) Rep. Lina Ortego (D-El Paso) Rep. John Raney (R-Bryan)

Rep. Tracy King (D-Uvalde) Rep. Ed Thompson (R-Pearland) Rep. Doc Anderson (R-Waco) Rep. Rhetta Andrews Bowers (D-Rowlett) running for U.S. Congress Rep. Julie Johnson (D-Farmers Branch) running for U.S. Congress Rep. Carl Sherman (D-DeSoto) running for U.S. Senate

Of note, one of the March Primary races to watch will be Democrats U.S. Rep. Colin Allred of Dallas, State Sen. Roland Gutierrez of San Antonio, and State Rep. Carl Sherman of DeSoto will challenge U.S. Sen. Ted Cruz, GOP incumbent seeking reelection next year. As always, it is a pleasure to serve the Federation as your voice at the Texas Capitol.

Mental Health Professionals Loan Repayment Program

s reported by the Federation of Texas Psychiatry Public Policy Advisor, Eric Woomer, in the last publication of the Texas Psychiatrist, the Mental Health Loan Repayment Program receiving a significant increase in appropriations (from \$2 million over the previous

biennium to \$28 million for the next

The purpose of the Mental Health Professionals Loan Repayment Program is to encourage mental health professionals to practice in a Mental Health Professional Shortage Area (MHPSA) and provide services to individuals, groups, and families to help them manage and overcome their mental health challenges.

The application window for 2023-24 is now open. To begin your application you must create an account by going to CBPass at https://www1.highered.texas.gov/cbpass/.

Psychiatrists must be eligible to take the exam for board certification to receive their final year of repayment assistance.

DEA Extends Telehealth Flexibilities Through Dec 31, 2024

he Drug Enforcement Administration (DEA) and the Department of Health and Human Services (HHS) have jointly announced a second temporary extension of telehealth flexibilities related to the prescription of controlled medications in response to the COVID-19 pandemic. These flexibilities provide exceptions to the existing DEA regulations and will now remain in

effect through December 31, 2024.

Under these extended telemedicine flexibilities, healthcare practitioners are authorized to prescribe schedule II-V controlled medications through audiovideo telemedicine encounters. This includes the prescription of III-V narcotic-controlled medications that have been approved by the FDA for the treatment

of opioid use disorder via audio-only telemedicine encounters.

The DEA is actively assessing feedback received during the comment period for a proposed rule and from listening sessions that took place in September. Their goal is to develop and implement new standards or safeguards related to telehealth practices by the fall of 2024.

This extension of telehealth flexibilities is part of the ongoing efforts to adapt healthcare practices to the challenges posed by the COVID-19 pandemic and to ensure continued access to necessary medications and medical care through telemedicine. It provides healthcare providers with the flexibility needed to deliver care remotely while maintaining regulatory oversight and patient safety.


